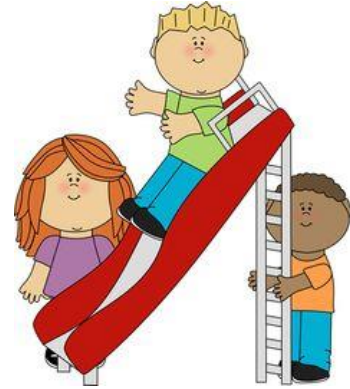

Child Development is the study of children and their growth and development as they move through various stages of life. Students will receive practical, usable skills to assist them in becoming better educated and better prepared caregivers, siblings, parents, and citizens. The Units we will cover throughout this semester in Child Development are as follows:

1. Parenting
2. Prenatal and Birth Defects
3. Pregnancy and Childbirth
4. The First Year
5. Toddler and Preschooler
6. Guidance Techniques and Coping with Difficult Situations

Required Equipment/Supplies:

- 3-Ring Binder OR Folder, Paper, Pen or Pencil

Grading Standards (Absent/Late Work):

The students will be graded on assignments/projects (40%), quizzes and tests (50%), and participation points (10%). **Late assignments will receive a 10% deduction from their total points up to 2 weeks. Past 2 weeks they will receive a 50% deduction. Grade specifications will be given depending on the assignment.** Students can talk to me about extra credit if needed.

It is the student's responsibility to check on missed work if he/she is absent and to check their grade on SIS. Students who have an excused absence have 2 weeks to turn in any work missed without point deduction. Past the 2 weeks there will be a 50% point deduction. If a student is gone for a test, then they have a week to make it up for full points. The date will be written on the board. After that week then they will lose 50% of their points. Unexcused absences will receive 50% on any assignment turned in. **All late/absent work is due one week before the end of the term.** If a student is going to be absent for an extended period of time, please talk with Miss Huffaker. At the end of the class students will take the State Test that is related to this course. This will be counted as our class final. Lifesavers may be used to receive full points on any assignment.

Assignments:

A wide variety of activities, projects, computer time, group interaction, and guest speakers will enhance learning in this course. The students need to keep up with their assignments. A variety of teaching materials

including some clips from G and PG rated videos and YouTube will be used. During our childbirth unit we will be watching some childbirth video clips and during our preschool unit we will be watching the movie "Daddy Day Care".

Grading Procedures on Assignments:

From time to time the students will do work that I feel is beneficial to have other student's grade or critique. Also, some work needs to be graded by students or teacher aids in class in order to facilitate time restraints. Those found not correcting assignments accurately will not receive credit for the assignments. No cheating will be tolerated. All work must be legible. Homework returned due to legibility must be resubmitted by the following school day. Some assignments must be typed.

Hall Pass:

Each student will be given three "Lifesavers" on the first day of each term. *You cannot use the hall pass without it!* These will be used as tokens for the hall pass with permission from the teacher. If the student does not use these "Lifesavers" they can apply them as extra credit at the end of the term. Please plan accordingly. The lifesaver may also be used to turn in one late assignment per lifesaver. The lifesaver must be stapled to the late assignment.

Citizenship:

All of the school guidelines as outlined in the student handbook and website will be followed. Students who copy or cheat will be given no credit on the assignment and will not receive participation points for the day, with a possibility of being sent to the office.

Class Procedures:

1. BRING ALL NEEDED MATERIALS TO CLASS: binder, paper, pen/pencil
2. BE READY TO WORK WHEN THE BELL RINGS. Students will be prepared to do bell work.
3. RESPECT AND BE POLITE TO ALL PEOPLE. Students will demonstrate respect for the teacher and other students in the class. I attend class to teach and the students should attend class to learn. Disruptive behavior will not be tolerated. Appropriate behavior includes: listening carefully when the teacher or another student is speaking, and refraining from threatening, coercing, intimidating, or annoying any student or staff. NO CELL PHONES OR IPODS ARE ALLOWED IN CLASS.
4. RESPECT OTHER'S PROPERTY. Students will demonstrate care and respect for classroom property and the property of other students. This includes, keeping the classroom neat and clean, not writing on the tables, and being careful with equipment. Damage caused by irresponsible behavior will be the responsibility of the offending student to rectify.
5. OBEY ALL SCHOOL AND CLASS RULES. Students will abide by the school's policies on dress and grooming, harmful illegal substances, fighting, vulgarity and profanity.

Dear Parent/Guardian:

As part of your child's education, he/she has enrolled in a course that includes instruction on topics related to human sexuality. You are receiving this consent form because instruction and/or discussion of human sexuality topics are controlled by state law and/or Utah State Board of Education rule. Please read the form carefully, select **one option**, sign, and return to the teacher identified above. Your student will not be allowed to participate in class activities without this completed and signed form on file. Thank you.

INFORMATION

All instruction related to human sexuality and/or sexual activity will take place within the context of Utah State Law (53A-13-101) and Utah State Board of Education rule (R277-474) as follows:

- The public schools will teach sexual abstinence before marriage and fidelity after marriage.
- There will be prior parental consent before teaching any aspect of contraception and/or condoms.
- Students will learn about communicable diseases, including those transmitted sexually, and HIV/AIDS.

Program materials and guest speakers supporting instruction on these topics have been reviewed and approved by the local district review committee.

The following are NOT approved by the State Board of Education for instruction and may not be taught:

- The intricacies of intercourse, sexual stimulation or erotic behavior;
- The advocacy of homosexuality;
- The advocacy or encouragement of the use of contraceptive methods or devices;
- The advocacy of sexual activity outside of marriage.

In accordance with Utah State Board of Education Rule R277-474-6-D, teachers may respond to spontaneous student questions for the purposes of providing accurate data or correcting inaccurate or misleading information or comments made by students in class regarding human sexuality.
